## HOW TO GET A TITLE FOR YOUR LEASE PURCHASE

When a lease vehicle is paid off, the payoff party must provide all of the following to get the vehicle title:

- Odometer statement
- Title release instructions (where to send the title)
- Damage Disclosure form (required for residents of Iowa, Minnesota, New York and North Carolina)

If the title has been released and the payoff party needs a duplicate, they can request one through [getmycartitle.com/gmfinancial](https://getmycartitle.com/gmfinancial) for a fee. The payoff party will need the VIN and the state the vehicle is titled in.
